

Hospital given £1.2m for health research



Rural and Coastal Research

The Trust, in partnership with the University of Birmingham and University of York, has been awarded £1.2 million in funding from the National Institute of Health Research to improve urgent and emergency care in rural coastal areas across the United Kingdom!

Dr Bella Scantlebury (University of Birmingham), Professor Joy Adamson (University of York) and the Trust's Scarborough Coastal Health and Care Research Collaborative (initiative are leading this project.

Dr Scantlebury and Prof. Adamson were interviewed This Is The Coast about this exciting project and work the universities and SHARC are doing to tackle health inequalities in coastal and rural regions within the UK. Rebecca Blakey from SeeCHANGE shared: "This is a welcome change for our communities. It will help staff provide the right care for patients and improve understanding of how emergency services can cope with demand."

Research Practitioner Scholarship

In December we advertised the Research Practitioner Scholarship backfill. The programmed sought applications to backfill time for the development of new research projects, systematic review, and the development of ERCs to pump prime their own research projects with the aim of these becoming larger projects in the future aligned to our SHARC Project.


Alongside YSJU's Institute of Health and Care Improvement, we awarded three projects within the Trust all with the aim of tackling health inequalities within the broader community.

Three projects were awarded in this call. The first to Clinical Stroke Nurse Specialist, Carol Wood, who will be investigating what is considered best practice when managing nasogastric feeding tubes and how to prevent dislodgment and reduced nutritional intake.

The second project was awarded to Research OT, Laura Wendon, who will conduct a qualitative interview study to explore the experiences of OTs and their perspectives on the barriers faced by higher-weight patients in acute hospital settings.

The Third project was warded to Research Midwife, Clare Panaser, who will engage in PPI to better understand how women currently prepare for pregnancy and identify barrers and facilitators to breastfeeding.

We look forward to seeing the outcomes of these projects, and thank the judging panel for the review of the applications. A second call will be released later this year.



PhD Student Success

Trust PhD student, Jamie Squire, recently has his Letter published in the British Medical Journal which disseminated his work on Advanced Clinical Practitioners in Emergency Medicine. Jamie, alongside the research Team and The University of York, designed an electronic census for ACPs to self report their role within the work force across regions in the UK.

Previous census data of the ACP workforce lacked information regarding locations, and profession status of ACPs. This updated census found nurses, then paramedics were the highest reported base professions across all regions. However, the census also revealed a broader range of professions (including physiotherapists and pharmacists) thus reflecting the RCEM position change and progression since previous reporting.
